In re Holocaust Victim Assets Litigation  
Case No. CV96-4849

## **Certified Denial**

to Claimant Paul Dermer

**Claimed Account Owner: Sara Dermer<sup>1</sup>**

Claim Number: 004957/MG

This Certified Denial is to the claim of Paul Dermer (the “Claimant”) to a Swiss bank account potentially owned by the Claimant’s relative, Sara Dermer (the “Claimed Account Owner”).

All denials are published. Where a claimant has not requested confidentiality, as in this case, only the name of the bank has been redacted.

### **Information Provided by the Claimant**

The Claimant submitted a claim stating that Sara Dermer was Jewish. The Claimant did not provide any further details about his relative, however during a telephone conversation with the CRT on 24 September 2002, the Claimant indicated that Dermer was his relative’s married name, and that she married a cousin of his father, Markus Dermer. The Claimant also indicated that his relative resided in Czernowitz, Romania (today, the Ukraine) and later moved to Poland.

### **The CRT’s Investigation**

The CRT matched the name of Sara Dermer to the names of all account owners in the Account History Database and identified accounts belonging to individuals whose names match, or are substantially similar to, the name of the Claimed Account Owner. In doing so, the CRT used advanced name matching systems and computer programs, and considered variations of names, including name variations provided by Yad Vashem, The Holocaust Martyrs’ and Heroes’ Remembrance Authority, in Jerusalem, Israel, to ensure that all possible name matches were identified. However, a close review of the relevant bank records indicated that the information contained therein was inconsistent with the information the Claimant provided regarding the Claimed Account Owner. Accordingly, the CRT was unable to conclude that any of these accounts belonged to the Claimed Account Owner.

<sup>1</sup> The Claimant should note that this determination relates only to the Claim Number and Claimed Account Owner stated above, and that the CRT is aware that the Claimant may have submitted other claims.

## The CRT's Analysis

### Identification of the Account Owner

The list below contains names of account owners that match the name of the Claimed Account Owner and the reasons why the CRT has concluded that the Claimed Account Owner and an account owner are not the same person. If an account owner's place of residence was published, that place of residence is also listed.

*Name: Sara Dermer (Poland)<sup>2</sup>*

*Account Identification Number: 1000621*

*Specifically, the Claimant indicated that his relative's married name was Dermer, and that she resided in Czernowitz, Romania (today, the Ukraine) and later moved to Poland. In contrast, the records show that the account owner had a different marital status and resided in a city which is more than 400 kilometers from Czernowitz.*

### Right of Appeal and Request for Reconsideration

Pursuant to Article 30 of the Rules Governing the Claims Resolution Process, as amended (the "Rules"), the Claimant may appeal this decision or submit a request for reconsideration within ninety (90) days of the date of the letter accompanying this decision.

An appeal must be based upon a plausible suggestion of error regarding the CRT's conclusions set out in this decision. Any appeals which are submitted without a plausible suggestion of error shall be summarily denied. A request for reconsideration must be based on new documentary evidence not previously presented to the CRT that, if considered, would have led to a different outcome of the claim. Claimants should briefly explain the relevance of the newly submitted documents in view of the conclusions stated in the certified decision.

If more than one account has been treated in this decision, the Claimant should identify the account, including, where available, the Account Identification Number, that forms the basis of the appeal and/or request for reconsideration.

<sup>2</sup> The CRT notes that, on the February 2001 published list of accounts determined by the Independent Committee of Eminent Persons ("ICEP") to be probably or possibly those of Victims of Nazi Persecution (the "ICEP List"), Sara Dermer is indicated as having a residence in Poland. Upon careful review, the CRT has concluded that the Bank's records evidence that the account owner resided in a different country.

**Scope of the Denial**

The CRT now considers the Claimant's claim to the accounts of Sara Dermer closed. Please note that this decision applies only to the Claim Number and Claimed Account Owner identified herein, and that the CRT is aware that the Claimant may have claimed accounts held by other persons or entities both in the Claim Number specified above and in other claims submitted to the CRT.
