Claimed Account Owner: Emma Elsner¹

This Certified Denial is to the claim of [REDACTED], née [REDACTED] (the “Claimant”) to a Swiss bank account potentially owned by the Claimant’s relative, Emma Elsner, née Meyer (the “Claimed Account Owner”).

All denials are published, but where a claimant has requested confidentiality, as in this case, the names of the claimant, any relatives of the claimant other than the account owner, and the bank have been redacted.

Information Provided by the Claimant

The Claimant submitted a claim stating that her mother, Emma Meyer, who was Jewish, had the maiden name Meyer, was married to [REDACTED] since 30 November 1920, and resided in Frankfurt am Main, Germany, until 1939, when she fled to Shanghai, China.

The CRT’s Investigation

The CRT matched the name of Emma Elsner, née Meyer, to the names of all account owners in the Account History Database and identified accounts belonging to individuals whose names match, or are substantially similar to, the name of the Claimed Account Owner. In doing so, the CRT used advanced name matching systems and computer programs, and considered variations of names, including name variations provided by Yad Vashem, The Holocaust Martyrs’ and Heroes’ Remembrance Authority, in Jerusalem, Israel, to ensure that all possible name matches were identified. However, a close review of the relevant bank records indicated that the information contained therein was inconsistent with the information the Claimant provided regarding the Claimed Account Owner. Accordingly, the CRT was unable to conclude that any of these accounts belonged to the Claimed Account Owner.

The CRT's Analysis

Identification of the Account Owners

The list below contains names of account owners that match the name of the Claimed Account Owner and the reasons why the CRT has concluded that the Claimed Account Owners and an account owner are not the same person. If an account owner's place of residence was published, that place of residence is also listed.

Name: Meyer, Emmy [Freiburg, Germany]

Account Identification Number: 5030372

Specifically, the Claimant stated that her mother's maiden name was Meyer. In contrast, the records show that the account owner had a different maiden name.

Name: Meyer, Emma [Heitersheim, Germany]

Account Identification Number: 5027413

Specifically, the Claimant stated that her mother, Emma Meyer, resided in Frankfurt am Main. In contrast, the records show that the account owner resided in Heitersheim, which is over 280 kilometers from Frankfurt am Main. The CRT notes that Frankfurt am Main is a major urban center and that the account owner resided in a relatively small city, rendering it unlikely that a resident of Frankfurt am Main would indicate the account owner's distant city as her residence, even for the purposes of maintaining a Swiss bank account.

Name: Meyer, Emma [Germany]

Account Identification Number: 1012835

Specifically, the Claimant stated that her mother, Emma Meyer, resided in Frankfurt am Main. In contrast, the records show that the account owner resided in a different city, which is over 350 kilometers from Frankfurt am Main. The CRT notes that Frankfurt am Main is a major urban center and that the account owner resided in a relatively small city, rendering it unlikely that a resident of Frankfurt am Main would indicate the account owner's distant city as her residence, even for the purposes of maintaining a Swiss bank account.

Name: Meyer, Emmy

Account Identification Number: 1011547

Specifically, the Claimant stated that her mother, Emma Meyer, married in 1920, after which she took the name Elsner. In contrast, the records show that the account owner had the last name Meyer many years after the claimant's mother married.

Name: Meyer, E. J. [Germany]

Account Identification Number: 1012905

Specifically, the Claimant stated that her mother, Emma Meyer, resided in Frankfurt am Main. In contrast, the records show that the account owner resided in a different city, which is over 500 kilometers from Frankfurt am Main.

The Claimant should note that all accounts awarded by the CRT are published upon release on the CRT's website at www.crt-ii.org.

Right of Appeal and Request for Reconsideration

Pursuant to Article 30 of the Rules Governing the Claims Resolution Process, as amended (the “Rules”), the Claimant may appeal this decision or submit a request for reconsideration within ninety (90) days of the date of the letter accompanying this decision.

An appeal must be based upon a plausible suggestion of error regarding the CRT’s conclusions set out in this decision. Any appeals which are submitted without a plausible suggestion of error shall be summarily denied. A request for reconsideration must be based on new documentary evidence not previously presented to the CRT that, if considered, would have led to a different outcome of the claim. Claimants should briefly explain the relevance of the newly submitted documents in view of the conclusions stated in the certified decision.

If more than one account has been treated in this decision, the Claimant should identify the account, including, where available, the Account Identification Number, that forms the basis of the appeal and/or request for reconsideration.

Scope of the Denial

The CRT now considers the Claimant’s claim to the accounts of Emma Elsner closed. Please note that this decision applies only to the Claim Number and Claimed Account Owner identified herein, and that the CRT is aware that the Claimant may have claimed accounts held by other persons or entities both in the Claim Number specified above and in other claims submitted to the CRT.
