In re Holocaust Victim Assets Litigation
Case No. CV96-4849

Certified Denial

to Claimant Petr Ditko

Claimed Account Owner: Janina Felix¹

Claim Number: 207360/SB

This Certified Denial is to the claim of Petr Ditko (the “Claimant”) to a Swiss bank account potentially owned by the Claimant’s relative, Janina Felix (the “Claimed Account Owner”).

All denials are published. Where a claimant has not requested confidentiality, as in this case, only the name of the bank has been redacted.

Information Provided by the Claimant

The Claimant provided very limited information in his claim regarding his relative, Janina Felix, only stating that she was Jewish and that she was his mother’s aunt. The CRT notes that while the Claimant did not indicate where Janina Felix resided, the Claimant consistently indicated that the Felix family resided in Czechoslovakia. In support of his claim, the Claimant submitted his mother’s certificate of residence (“*Heimatschein*”), dated 1944, which indicates that she lived in Dries Drisy, which was located in Czechoslovakia and is now located in the Czech Republic. The CRT notes that all the documents provided by the Claimant indicate that his family resided in Czechoslovakia.

The CRT’s Investigation

The CRT matched the name of Janina Felix to the names of all account owners in the Account History Database and identified accounts belonging to individuals whose names match, or are substantially similar to, the name of the Claimed Account Owner. In doing so, the CRT used advanced name matching systems and computer programs, and considered variations of names, including name variations provided by Yad Vashem, The Holocaust Martyrs’ and Heroes’ Remembrance Authority, in Jerusalem, Israel, to ensure that all possible name matches were identified. However, a close review of the relevant bank records indicated that the information contained therein was inconsistent with the information the Claimant provided regarding the

Claimed Account Owner. Accordingly, the CRT was unable to conclude that any of these accounts belonged to the Claimed Account Owner.

The CRT's Analysis

Identification of the Account Owner

The list below contains names of account owners that match the name of the Claimed Account Owner and the reasons why the CRT has concluded that the Claimed Account Owner and an account owner are not the same person.

Name: Janina Felix

Account Identification Numbers: 1009129 and 1009130

Specifically, the Claimant consistently stated that the Felix family resided in Czechoslovakia. The CRT notes that on the February 2001 published list of accounts determined by the Independent Committee of Eminent Persons ("ICEP") to be probably or possibly those of Victims of Nazi Persecution (the "ICEP List"), Janina Felix is indicated as residing in Czechoslovakia. Upon careful review of the account records, however, the CRT has concluded that the account owner's place of residence was mispublished on the ICEP List. According to the records, the account owner did not reside in Czechoslovakia, but in a city in another country, which the Claimant did not identify. The CRT notes that this city historically was never part of Czechoslovakia.

The Claimant should note that all accounts awarded by the CRT are published upon release on the CRT's website at www.crt-ii.org.

Right of Appeal and Request for Reconsideration

Pursuant to Article 30 of the Rules Governing the Claims Resolution Process, as amended (the "Rules"), the Claimant may appeal this decision or submit a request for reconsideration within ninety (90) days of the date of the letter accompanying this decision.

An appeal must be based upon a plausible suggestion of error regarding the CRT's conclusions set out in this decision. Any appeals which are submitted without a plausible suggestion of error shall be summarily denied. A request for reconsideration must be based on new documentary evidence not previously presented to the CRT that, if considered, would have led to a different outcome of the claim. Claimants should briefly explain the relevance of the newly submitted documents in view of the conclusions stated in the certified decision.

If more than one account has been treated in this decision, the Claimant should identify the account, including, where available, the Account Identification Number, that forms the basis of the appeal and/or request for reconsideration.

Scope of the Denial

The CRT now considers the Claimant's claim to the accounts of Janina Felix closed. Please note that this decision applies only to the Claim Number and Claimed Account Owner identified herein, and that the CRT is aware that the Claimant may have claimed accounts held by other persons or entities both in the Claim Number specified above and in other claims submitted to the CRT.

Certification of the Denial

The CRT certifies this Denial for approval by the Court.
