In re Holocaust Victim Assets Litigation
Case No. CV96-4849

Certified Denial

to Claimant Otto Filz

Claimed Account Owners: Otto Filz, Rosa Filz and Joe Filz¹

Claim Number: 217026/NB

This determination is based on the claim of Otto Filz (the Claimant) to a Swiss bank account potentially owned by Otto Filz, Joe Filz and Rosa Filz. The CRT did not locate an account belonging to Otto Filz (Filzberg, Fieldberg, Fieldburg) and Joe (Josef) Filz in the Account History Database prepared pursuant to the investigation of the Independent Committee of Eminent Persons (ICEP or ICEP Investigation), which identified accounts probably or possibly belonging to Victims of Nazi Persecution, as defined in the Rules Governing the Claims Resolution Process, as amended (the Rules).

This Certified Denial is to a Swiss bank account potentially owned by the Claimant's mother, Rosa (Rose, Rosina) Filz (Maier, Mair, Blum, Koop) (the "Claimed Account Owner").

All denials are published. Where a claimant has not requested confidentiality, as in this case, only the name of the bank has been redacted.

Information Provided by the Claimant

The Claimant submitted a claim stating that his mother, Rosa Filz, who was Jewish, had the maiden name Maier and was born on 28 November 1907.

The CRT's Investigation

The CRT matched the name of Rosa (Rose, Rosina) Filz (Maier, Mair, Blum, Koop) to the names of all account owners in the Account History Database and identified accounts belonging to individuals whose names match, or are substantially similar to, the name of the Claimed Account Owner. In doing so, the CRT used advanced name matching systems and computer programs, and considered variations of names, including name variations provided by Yad Vashem, The Holocaust Martyrs' and Heroes' Remembrance Authority, in Jerusalem, Israel, to ensure that all possible name matches were identified. However, a close review of the relevant

bank records indicated that the information contained therein was inconsistent with the information the Claimant provided regarding the Claimed Account Owner. Accordingly, the CRT was unable to conclude that any of these accounts belonged to the Claimed Account Owner.

The CRT's Analysis

Identification of the Account Owner

The list below contains names of account owners that match the name of the Claimed Account Owner and the reasons why the CRT has concluded that the Claimed Account Owner and an account owner are not the same person. If an account owner's place of residence was published, that place of residence is also listed.

Name: Rosa Maier

Account Identification Number: 1001266

Specifically, the Claimant stated that his mother, Rosa Filz, was born on 28 November 1907. In contrast, the records show that the account owner was born many years after the Claimant's mother.

The CRT has taken utmost care in matching the names of the person identified by the Claimant as a possible account owner to names of actual account owners identified in the Account History Database prepared pursuant to the investigation of the Independent Committee of Eminent Persons (ICEP or ICEP Investigation), which identified accounts probably or possibly belonging to Victims of Nazi Persecution, as defined in the Rules Governing the Claims Resolution Process, as amended (the Rules). The CRT has reviewed this claim carefully and analyzed matches to accounts belonging to account owners with alternative spellings of Rosa Filz' maiden name Maier, which include Mayer, and has determined that these accounts did not belong to the Claimed Account Owner.

Right of Appeal and Request for Reconsideration

Pursuant to Article 30 of the Rules Governing the Claims Resolution Process, as amended (the "Rules"), the Claimant may appeal this decision or submit a request for reconsideration within ninety (90) days of the date of the letter accompanying this decision.

An appeal must be based upon a plausible suggestion of error regarding the CRT's conclusions set out in this decision. Any appeals which are submitted without a plausible suggestion of error shall be summarily denied. A request for reconsideration must be based on new documentary evidence not previously presented to the CRT that, if considered, would have led to a different outcome of the claim. Claimants should briefly explain the relevance of the newly submitted documents in view of the conclusions stated in the certified decision.

Scope of the Denial

The CRT now considers the Claimant's claim to the accounts of Rosa Filz closed. Please note that this decision applies only to the Claim Number and Claimed Account Owner identified herein, and that the CRT is aware that the Claimant may have claimed accounts held by other persons or entities both in the Claim Number specified above and in other claims submitted to the CRT.

Certification of the Denial
