In re Holocaust Victim Assets Litigation
Case No. CV96-4849

Certified Denial

to Claimant [REDACTED]

Claimed Account Owners: Hermine Fraenkel and Caecilie Fraenkel¹

Claim Number: 400354/NB

This determination is based on the claim of [REDACTED] (the Claimant) to Swiss bank accounts potentially owned by the Claimant s relatives, Hermine Fraenkel and Caecilie Fraenkel (the “Claimed Account Owners”).

All denials are published, but where a claimant has requested confidentiality, as in this case, the names of the claimant, any relatives of the claimant other than the account owner, and the bank have been redacted.

Information Provided by the Claimant

The Claimant submitted a claim stating that her family escaped from Berlin, Germany to Novi Sad, Yugoslavia in 1934, after Hitler’s rise to power. The Claimant explained that her brother, [REDACTED], who was born in Pécs, Hungary, was Jewish, and that he worked as a stamp dealer with his father, [REDACTED] in Novi Sad, until 1941, when he was forced to perform slave labor.

The CRT notes that the Claimant did not provide any additional information regarding her relatives, Hermine Fraenkel and Caecilie Fraenkel. Specifically, the Claimant did not explain how she was related to these persons and provided no information regarding where they resided or their fate.

The CRT’s Investigation

The CRT matched the name of Hermine Fraenkel and Caecilie Fraenkel to the names of all account owners in the Account History Database and identified accounts belonging to individuals whose names match, or are substantially similar to, the name of the Claimed Account Owner. In doing so, the CRT used advanced name matching systems and computer programs, and considered variations of names, including name variations provided by Yad Vashem, The Holocaust Martyrs’ and Heroes’ Remembrance Authority, in Jerusalem, Israel, to ensure that all possible name matches were identified. However, a close review of the relevant bank records

indicated that the information contained therein was inconsistent with the information the Claimant provided regarding the Claimed Account Owner. Accordingly, the CRT was unable to conclude that any of these accounts belonged to the Claimed Account Owner.

The CRT's Analysis

Identification of the Account Owner

The list below contains names of account owners that match the name of the Claimed Account Owner and the reasons why the CRT has concluded that the Claimed Account Owner and an account owner are not the same person. If an account owner's place of residence was published, that place of residence is also listed.

Name: Cäcilie Fränkel

Account Identification Number: 5034262

Specifically, although the Claimant did not state where her relative Caecilie Fraenkel resided, she did state that her family resided in Hungary, Germany, and Yugoslavia. In contrast, the records indicate that the account owner resided in a different country. The CRT further notes that the Claimant did not identify the power of attorney holder, who was closely related to the account owner.

Name: Hermine Fränkel

Account Identification Number: 4020261

Specifically, although the Claimant did not state where her relative Hermine Fraenkel resided, she did state that her family resided in Pécs, Hungary, Berlin, Germany, and Novi Sad, Yugoslavia. In contrast, the records indicate that the account owner resided in a different city in Germany, which is more than 500 kilometers from Berlin.

The Claimant should note that all accounts awarded by the CRT are published upon release on the CRT's website at www.crt-ii.org.

Right of Appeal and Request for Reconsideration

Pursuant to Article 30 of the Rules Governing the Claims Resolution Process, as amended (the "Rules"), the Claimant may appeal this decision or submit a request for reconsideration within ninety (90) days of the date of the letter accompanying this decision.

An appeal must be based upon a plausible suggestion of error regarding the CRT's conclusions set out in this decision. Any appeals which are submitted without a plausible suggestion of error shall be summarily denied. A request for reconsideration must be based on new documentary evidence not previously presented to the CRT that, if considered, would have led to a different outcome of the claim. Claimants should briefly explain the relevance of the newly submitted documents in view of the conclusions stated in the certified decision.

Scope of the Denial

The CRT now considers the Claimant's claim to the accounts of Hermine Fraenkel and Caecilie Fraenkel closed. Please note that this decision applies only to the Claim Number and Claimed Account Owners identified herein, and that the CRT is aware that the Claimant may have claimed accounts held by other persons or entities both in the Claim Number specified above and in other claims submitted to the CRT.
