In re Holocaust Victim Assets Litigation  
Case No. CV96-4849

## **Certified Denial**

to Claimant Catherine Allouche

**Claimed Account Owner: Georges Frank<sup>1</sup>**

Claim Number: 222130/SB

This Certified Denial is to the claim of Catherine Allouche (the “Claimant”) to a Swiss bank account potentially owned by the Claimant’s relative, Georges (Georg) Frank (the “Claimed Account Owner”).

All denials are published. Where a claimant has not requested confidentiality, as in this case, only the name of the bank has been redacted.

### **Information Provided by the Claimant**

The Claimant submitted a claim stating that Georges Frank, who was Jewish, resided in Germany until sometime prior to the outbreak of the Second World War, when he fled to France. The Claimant further stated that Georges Frank resided in Clermont-Ferrand, Marseille, and Colmar in France. The CRT notes that the Claimant did not indicate where Georges Frank resided in Germany, but did indicate that he was born in Sogel, Germany.

### **The CRT’s Investigation**

The CRT matched the name of Georges (Georg) Frank to the names of all account owners in the Account History Database and identified accounts belonging to individuals whose names match, or are substantially similar to, the name of the Claimed Account Owner. In doing so, the CRT used advanced name matching systems and computer programs, and considered variations of names, including name variations provided by Yad Vashem, The Holocaust Martyrs’ and Heroes’ Remembrance Authority, in Jerusalem, Israel, to ensure that all possible name matches were identified. However, a close review of the relevant bank records indicated that the information contained therein was inconsistent with the information the Claimant provided regarding the Claimed Account Owner. Accordingly, the CRT was unable to conclude that any of these accounts belonged to the Claimed Account Owner.

## **The CRT's Analysis**

### Identification of the Account Owners

The list below contains names of account owners that match the name of the Claimed Account Owner and the reasons why the CRT has concluded that the Claimed Account Owner and an account owner are not the same person. If an account owner's place of residence was published, that place of residence is also listed.

*Name: Georges Frank (Paris, France)*

*Account Identification Numbers: 4020209 and 4020210*

*Specifically, the Claimant stated that her relative, Georges Frank, resided in Clermont-Ferrand, Marseille and Colmar, France. In contrast, the records show that the account owner resided in Paris, France, which is over 350 kilometers from Clermont-Ferrand, Marseille and Colmar.*

*Name: Georg Frank (Germany)*

*Account Identification Number: 1011955*

*Specifically, whilst the Claimant did not indicate which city in Germany her relative, Georges Frank, resided before fleeing to France, the Claimant did indicate that her relative was born in Sogel, Germany. In contrast, the records show that the account owner resided in a different city, which the Claimant did not identify and which is over 400 kilometers from Sogel.*

### Right of Appeal and Request for Reconsideration

Pursuant to Article 30 of the Rules Governing the Claims Resolution Process, as amended (the "Rules"), the Claimant may appeal this decision or submit a request for reconsideration within ninety (90) days of the date of the letter accompanying this decision.

An appeal must be based upon a plausible suggestion of error regarding the CRT's conclusions set out in this decision. Any appeals which are submitted without a plausible suggestion of error shall be summarily denied. A request for reconsideration must be based on new documentary evidence not previously presented to the CRT that, if considered, would have led to a different outcome of the claim. Claimants should briefly explain the relevance of the newly submitted documents in view of the conclusions stated in the certified decision.

If more than one account has been treated in this decision, the Claimant should identify the account, including, where available, the Account Identification Number, that forms the basis of the appeal and/or request for reconsideration.

**Scope of the Denial**

The CRT now considers the Claimant's claim to the accounts of Georges Frank closed. Please note that this decision applies only to the Claim Number and Claimed Account Owner identified herein, and that the CRT is aware that the Claimant may have claimed accounts held by other persons or entities both in the Claim Number specified above and in other claims submitted to the CRT.
