**Claimed Account Owners: Martha Frank, Marianne Frank, Ernst Maass
and Walter Maass¹**

Claim Number: 401085/MG

This Certified Denial is to the claim of [REDACTED] (the “Claimant”) to Swiss bank accounts published on the list of account owners in 2005 and potentially owned by Martha Frank, Marianne Frank, Ernst Maass and Walter Maass (the “Claimed Account Owners”).

All denials are published, but where a claimant has requested confidentiality, as in this case, the names of the claimant, any relatives of the claimant other than the account owner, and the bank have been redacted.

Information Provided by the Claimant

The Claimant submitted a claim indicating that Martha Frank, Marianne Frank, Ernst Maass and Walter Maass were Jewish. The Claimant indicated that Martha Frank resided in Germany and Austria, that Marianne Frank resided in Germany, and that Ernst Maass and Walter Maass were trustees to his family’s accounts.

The CRT’s Investigation

The CRT matched the names of Martha Frank, Marianne Frank, Ernst Maass and Walter Maass to the names of all account owners in the Account History Database and identified accounts belonging to individuals whose names match, or are substantially similar to, the name of the Claimed Account Owners. In doing so, the CRT used advanced name matching systems and computer programs, and considered variations of names, including name variations provided by Yad Vashem, The Holocaust Martyrs’ and Heroes’ Remembrance Authority, in Jerusalem, Israel, to ensure that all possible name matches were identified. However, a close review of the relevant bank records indicated that the information contained therein was inconsistent with the information the Claimant provided regarding the Claimed Account Owners. CRT was unable to conclude that any of these accounts belonged to the Claimed Account Owners.

The CRT's Analysis

Identification of the Account Owners

The list below contains names of account owners and/or power of attorney holders that match the name of the Claimed Account Owners and the reasons why the CRT has concluded that a Claimed Account Owner and an account owner or a power of attorney holder are not the same person. If an account owner's place of residence was published, that place of residence is also listed.

Name: Martha Frank

Account Identification Number: 1009197

Specifically, the Claimant indicated that his relative, Martha Frank, resided in Germany and Austria . In contrast, the records show that the account owner resided in a different country.

Name: Marianne Frank

Account Identification Numbers: 5025697 and 5033610

Specifically, the Claimant indicated that his relative, Marianne Frank, resided in Germany. In contrast, the records show that the account owner resided in a different country.

Names: E. Maass (power of attorney holder); W. Maass (power of attorney holder)

Account Identification Number: 5029738

Specifically, the Claimant is claiming the account of his relatives, Ernst and Walter Maass. In contrast, the records show that the power of attorney holder E. Maass was female and that power of attorney holder W. Maass had a different first name.

Name: W. Maass (power of attorney holder)

Account Identification Numbers: 5029739

Specifically, the Claimant is claiming the account of his relative, Walter Maass. In contrast, the records show that the power of attorney holder had a different first name.

The Claimant should note that all accounts awarded by the CRT are published upon release on the CRT's website at www.crt-ii.org.

Right of Appeal and Request for Reconsideration

Pursuant to Article 30 of the Rules Governing the Claims Resolution Process, as amended (the "Rules"), the Claimant may appeal this decision or submit a request for reconsideration within ninety (90) days of the date of the letter accompanying this decision.

An appeal must be based upon a plausible suggestion of error regarding the CRT's conclusions set out in this decision. Any appeals which are submitted without a plausible suggestion of error

shall be summarily denied. A request for reconsideration must be based on new documentary evidence not previously presented to the CRT that, if considered, would have led to a different outcome of the claim. Claimants should briefly explain the relevance of the newly submitted documents in view of the conclusions stated in the certified decision.

If more than one account has been treated in this decision, the Claimant should identify the account, including, where available, the Account Identification Number, that forms the basis of the appeal and/or request for reconsideration.

Scope of the Denial

The CRT now considers the Claimant's claim to the accounts of Martha Frank, Marianne Frank, Ernst Maass and Walter Maass closed. Please note that this decision applies only to the Claim Number and Claimed Account Owners identified herein, and that the CRT is aware that the Claimant may have claimed accounts held by other persons or entities both in the Claim Number specified above and in other claims submitted to the CRT.

Certification of the Denial

The CRT certifies this Denial for approval by the Court.
