In re Holocaust Victim Assets Litigation
Case No. CV96-4849

Certified Denial

to Claimant Walter Simon Hahn

Claimed Account Owners: Hermann Hahn and Emma Hahn¹

Claim Number: 201372/RT

This determination is based on the claim of Walter Simon Hahn (the “Claimant”) to Swiss bank accounts potentially owned by Hermann Hahn and Emma Hahn. The CRT did not locate an account belonging to Hermann Hahn in the Account History Database prepared pursuant to the investigation of the Independent Committee of Eminent Persons (“ICEP” or “ICEP Investigation”), which identified accounts probably or possibly belonging to Victims of Nazi Persecution, as defined in the Rules Governing the Claims Resolution Process, as amended (the “Rules”).

This Certified Denial is to a Swiss bank account potentially owned by the Claimant’s mother, Emma Hahn (Mayer) (the “Claimed Account Owner”).

All denials are published. Where a claimant has not requested confidentiality, as in this case, only the name of the bank has been redacted.

Information Provided by the Claimant

The Claimant submitted a claim stating that his mother, Emma Hahn, who was Jewish, had the maiden name Mayer and resided in Auerbach-Bensheim, Germany. The Claimant further stated that he was born on 20 August 1933, indicating that his parents were married no later than August 1933.

The CRT’s Investigation

The CRT matched the name of Emma Hahn (Mayer) to the names of all account owners in the Account History Database and identified accounts belonging to individuals whose names match, or are substantially similar to, the name of the Claimed Account Owner. In doing so, the CRT used advanced name matching systems and computer programs, and considered variations of names, including name variations provided by Yad Vashem, The Holocaust Martyrs’ and

Heroes' Remembrance Authority, in Jerusalem, Israel, to ensure that all possible name matches were identified. However, a close review of the relevant bank records indicated that the information contained therein was inconsistent with the information the Claimant provided regarding the Claimed Account Owner. Accordingly, the CRT was unable to conclude that any of these accounts belonged to the Claimed Account Owner.

The CRT's Analysis

Identification of the Account Owner

The list below contains names of account owners that match the name of the Claimed Account Owner and the reasons why the CRT has concluded that the Claimed Account Owner and an account owner are not the same person. If an account owner's place of residence was published, that place of residence is also listed.

Name: Emma Hahn (Langenegg, Voralberg, Austria)

Account Identification Number: 2010043 and 2016022

Specifically, the Claimant stated that his mother, Emma Hahn, had the maiden name Mayer. In contrast the records show that the account owner had a different maiden name.

Name: E. Mayer

Account Identification Number: 1000867

Specifically, the Claimant indicated that his mother, Emma Hahn, married his father, Hermann Hahn, no later than August 1933, when the Claimant was born. In contrast, the records indicate that the account owner used the last name Mayer at a time when the Claimant's mother was already married and would not have used her maiden name any longer.

Name: E. Mayer (Germany)

Account Identification Number: 1012891

Specifically, the Claimant stated that his relative, Emma Hahn, married his father, Hermann Hahn, no later than August 1933, when the Claimant was born. In contrast, the records indicate that the account owner used the last name Mayer at a time when the Claimant's mother was already married and would not have used her maiden name any longer. The CRT notes that the Claimant did not identify the joint account owner, who was closely related to the account owner.

The CRT has taken utmost care in matching the names of the person identified by the Claimant as a possible account owner to names of actual account owners identified in the Account History Database prepared pursuant to the investigation of the Independent Committee of Eminent Persons ("ICEP" or "ICEP Investigation"), which identified accounts probably or possibly belonging to Victims of Nazi Persecution, as defined in the Rules Governing the Claims Resolution Process, as amended (the "Rules"). The CRT has reviewed this claim carefully and analyzed matches to accounts belonging to account owners with alternative spellings of Emma Hahn's maiden name, which include Maier, Meier and Meyer, and has determined that these accounts did not belong to the Claimed Account Owner.

The Claimant should note that all accounts awarded by the CRT are published upon release on the CRT's website at www.crt-ii.org.

Right of Appeal and Request for Reconsideration

Pursuant to Article 30 of the Rules Governing the Claims Resolution Process, as amended (the "Rules"), the Claimant may appeal this decision or submit a request for reconsideration within ninety (90) days of the date of the letter accompanying this decision.

An appeal must be based upon a plausible suggestion of error regarding the CRT's conclusions set out in this decision. Any appeals which are submitted without a plausible suggestion of error shall be summarily denied. A request for reconsideration must be based on new documentary evidence not previously presented to the CRT that, if considered, would have led to a different outcome of the claim. Claimants should briefly explain the relevance of the newly submitted documents in view of the conclusions stated in the certified decision.

If more than one account has been treated in this decision, the Claimant should identify the account, including, where available, the Account Identification Number, that forms the basis of the appeal and/or request for reconsideration.

Scope of the Denial

The CRT now considers the Claimant's claim to the accounts of Hermann Hahn and Emma Hahn closed. Please note that this decision applies only to the Claim Number and Claimed Account Owners identified herein, and that the CRT is aware that the Claimant may have claimed accounts held by other persons or entities both in the Claim Number specified above and in other claims submitted to the CRT.

Certification of the Denial

The CRT certifies this Denial for approval by the Court.
