In re Holocaust Victim Assets Litigation

Certified Denial

to Claimant [REDACTED]

**Claimed Account Owners: Otto Mandl, Albert Mandl, Emanuel Mandl
and Jakob Hirsch¹**

Claim Number: 200946/RT

This determination is based on the claim of [REDACTED] (the “Claimant”) to Swiss bank accounts potentially owned by Otto Mandl, Albert Mandl, Emanuel Mandl and Jakob Hirsch. The CRT did not locate an account belonging to Albert (Abraham) Mandl and Emanuel Mandl in the Account History Database prepared pursuant to the investigation of the Independent Committee of Eminent Persons (“ICEP” or “ICEP Investigation”), which identified accounts probably or possibly belonging to Victims of Nazi Persecution, as defined in the Rules Governing the Claims Resolution Process, as amended (the “Rules”).

This Certified Denial is to a Swiss bank account potentially owned by the Claimant’s relatives, Otto Mandl and Jakob Hirsch (the “Claimed Account Owners”).

All denials are published, but where a claimant has requested confidentiality, as in this case, the names of the claimant, any relatives of the claimant other than the account owner, and the bank have been redacted.

Information Provided by the Claimant

The Claimant submitted a claim stating that Otto Mandl, who was Jewish, was a sales representative who resided at Weihburggasse 4, Vienna 1, Austria, until 1915, and then Grünangergasse 3/13, Vienna 1 until 1939, when he fled Austria to Palestine (today Israel). The Claimant also submitted documents which contain Otto Mandel’s signature. The Claimant did not indicate where his relative, Jakob Hirsch, resided but did state that he was born on 25 May 1838 and died in 1915.

¹ The Claimant should note that this determination relates only to the Claim Number and Claimed Account Owners stated above, and that the CRT is aware that the Claimant may have submitted other claims.

The CRT's Investigation

The CRT matched the names of Otto Mandl and Jakob Hirsch to the names of all account owners in the Account History Database and identified accounts belonging to individuals whose names match, or are substantially similar to, the name of the Claimed Account Owners. In doing so, the CRT used advanced name matching systems and computer programs, and considered variations of names, including name variations provided by Yad Vashem, The Holocaust Martyrs' and Heroes' Remembrance Authority, in Jerusalem, Israel, to ensure that all possible name matches were identified. However, a close review of the relevant bank records indicated that the information contained therein was inconsistent with the information the Claimant provided regarding the Claimed Account Owners. Accordingly, the CRT was unable to conclude that any of these accounts belonged to the Claimed Account Owners.

The CRT's Analysis

Identification of the Account Owners

The list below contains names of account owners that match the names of the Claimed Account Owners and the reasons why the CRT has concluded that the Claimed Account Owners and an account owner are not the same person. If an account owner's place of residence was published, that place of residence is also listed.

Name: Otto Mandl (Austria)

Account Identification Numbers: 1011712; 1011713; 1011714

Specifically, the Claimant stated that his relative, Otto Mandl was born in 1911 and was employed as a sales representative. In contrast, the records show that the account owner held a professional or academic title at a time when the Claimant's relative was still a young person, and that this title is inconsistent with someone employed as a sales representative.

Name: Otto Mandl (Vienna, Austria)

Account Identification Number: 5035838

Specifically, the Claimant provided a copy of his relative's, Otto Mandl, signature. In contrast, the records show that the account owner had a very different signature. The CRT also notes that the Claimant stated that his relative resided at Weihburggasse 4, Vienna 1, Austria until 1915 and Grünangergasse 3/13, Vienna 1 until 1939, whereas the records indicate that at this time the account owner resided at a different street address.

Name: Jakob Hirsch (Noé, France)

Account Identification Number: 5034435

Specifically, the Claimant stated that his relative, Jakob Hirsch, died in 1915. In contrast, the records show that the account owner was alive several decades later.

The Claimant should note that all accounts awarded by the CRT are published upon release on the CRT's website at www.crt-ii.org.

Right of Appeal and Request for Reconsideration

Pursuant to Article 30 of the Rules, the Claimant may appeal this decision or submit a request for reconsideration within ninety (90) days of the date of the letter accompanying this decision.

An appeal must be based upon a plausible suggestion of error regarding the CRT's conclusions set out in this decision. Any appeals which are submitted without a plausible suggestion of error shall be summarily denied. A request for reconsideration must be based on new documentary evidence not previously presented to the CRT that, if considered, would have led to a different outcome of the claim. Claimants should briefly explain the relevance of the newly submitted documents in view of the conclusions stated in the certified decision.

If more than one account has been treated in this decision, the Claimant should identify the account, including, where available, the Account Identification Number, that forms the basis of the appeal and/or request for reconsideration.

Scope of the Denial

The CRT now considers the Claimant's claim to the accounts of Otto Mandl, Albert Mandl, Emanuel Mandl and Jakob Hirsch closed. Please note that this decision applies only to the Claim Number and Claimed Account Owners identified herein, and that the CRT is aware that the Claimant may have claimed accounts held by other persons or entities both in the Claim Number specified above and in other claims submitted to the CRT.
