In re Holocaust Victim Assets Litigation

Certified Denial

to Claimant [REDACTED]

Claimed Account Owner: Louis Meyer¹

Claim Numbers: 224442/SB; 300658/SB

This Certified Denial is to the claims of [REDACTED] (the “Claimant”) to a Swiss bank account potentially owned by the Claimant’s relative, Louis (Levi) Meyer (Meier, Maier, Mayer) (the “Claimed Account Owner”).

All denials are published, but where a claimant has requested confidentiality, as in this case, the names of the claimant, any relatives of the claimant other than the account owner, and the bank have been redacted.

Information Provided by the Claimant

The Claimant did not state where Louis Meyer, who was Jewish, actually resided, but the CRT notes that what information the Claimant does provide is consistent with Louis Meyer having resided in Gambach, Germany.

The CRT’s Investigation

The CRT matched the name of Louis (Levi) Meyer (Meier, Maier, Mayer) to the names of all account owners in the Account History Database and identified accounts belonging to individuals whose names match, or are substantially similar to, the name of the Claimed Account Owner. In doing so, the CRT used advanced name matching systems and computer programs, and considered variations of names, including name variations provided by Yad Vashem, The Holocaust Martyrs’ and Heroes’ Remembrance Authority, in Jerusalem, Israel, to ensure that all possible name matches were identified. However, a close review of the relevant bank records indicated that the information contained therein was inconsistent with the information the Claimant provided regarding the Claimed Account Owner. Accordingly, the CRT was unable to conclude that any of these accounts belonged to the Claimed Account Owner.

¹ The Claimant should note that this determination relates only to the Claim Numbers and Claimed Account Owner stated above, and that the CRT is aware that the Claimant may have submitted other claims.

The CRT's Analysis

Identification of the Account Owners

The list below contains names of account owners that match the name of the Claimed Account Owner and the reasons why the CRT has concluded that the Claimed Account Owner and an account owner are not the same person. If an account owner's place of residence was published, that place of residence is also listed.

Name: Louis Meyer (Mannheim, Germany)

Account Identification Number: 1001342

Specifically, the Claimant indicated that his relative, Louis Meyer, resided in Gambach, Germany. In contrast, the records show that the account owner resided in Mannheim which is approximately 100 kilometers from Gambach. The CRT notes that there are several other major cities closer to Gambach than Mannheim, thus rendering it unlikely that a resident of Gambach would indicate Mannheim as their place of residence even for the purposes of maintaining a Swiss bank account.

Name: Louis Meyer (Ingersheim, Germany)

Account Identification Number: 5024966

Specifically, the Claimant indicated that his relative, Louis Meyer, resided in Gambach, Germany. In contrast, the records show that the account owner resided in Ingersheim which is approximately 200 kilometers from Gambach. The CRT notes that there are several other major cities closer to Gambach than Ingersheim, thus rendering it unlikely that a resident of Gambach would indicate Ingersheim as their place of residence even for the purposes of maintaining a Swiss bank account.

The Claimant should note that all accounts awarded by the CRT are published upon release on the CRT's website at www.crt-ii.org.

Right of Appeal and Request for Reconsideration

Pursuant to Article 30 of the Rules Governing the Claims Resolution Process, as amended (the "Rules"), the Claimant may appeal this decision or submit a request for reconsideration within ninety (90) days of the date of the letter accompanying this decision.

An appeal must be based upon a plausible suggestion of error regarding the CRT's conclusions set out in this decision. Any appeals which are submitted without a plausible suggestion of error shall be summarily denied. A request for reconsideration must be based on new documentary evidence not previously presented to the CRT that, if considered, would have led to a different outcome of the claim. Claimants should briefly explain the relevance of the newly submitted documents in view of the conclusions stated in the certified decision.

treated in this decision, the Claimant should identify the account, including, where available, the Account Identification Number, that forms the basis of the appeal and/or request for reconsideration.

Scope of the Denial

The CRT now considers the Claimant's claims to the accounts of Louis Meyer closed. Please note that this decision applies only to the Claim Numbers and Claimed Account Owner identified herein, and that the CRT is aware that the Claimant may have claimed accounts held by other persons or entities both in the Claim Numbers specified above and in other claims submitted to the CRT.
