## **Certified Denial**

to Claimant [REDACTED]

**Claimed Account Owners: Olga Meyer, Adolf Meyer and Anna Meyer<sup>1</sup>**

Claim Number: 401610/RT

This Certified Denial is to the claim of [REDACTED] (the “Claimant”) to the Swiss bank accounts A. Meyer and Olga Meyer, as published on the list of account owners in 2005, and potentially owned by the Claimant’s relatives, Adolf or Anna Meyer and Olga Meyer (the “Claimed Account Owners”).

All denials are published, but where a claimant has requested confidentiality, as in this case, the names of the claimant, any relatives of the claimant other than the account owner, and the bank have been redacted.

### **Information Provided by the Claimant**

The Claimant submitted a claim stating that Olga Meyer, Adolf Meyer and Anna Meyer, who were Jewish, resided in Germany. The CRT notes that the Claimant did not provide much information about her relatives, but indicated that they also resided in the United States.

### **The CRT’s Investigation**

The CRT matched the names of Olga Meyer, Adolf Meyer and Anna Meyer to the names of all account owners and power of attorney holders in the Account History Database and identified accounts belonging to individuals or over which individuals held power of attorney, whose names match, or are substantially similar to, the name of the Claimed Account Owners. In doing so, the CRT used advanced name matching systems and computer programs, and considered variations of names, including name variations provided by Yad Vashem, The Holocaust Martyrs’ and Heroes’ Remembrance Authority, in Jerusalem, Israel, to ensure that all possible name matches were identified. However, a close review of the relevant bank records indicated that the information contained therein was inconsistent with the information the Claimant provided regarding the Claimed Account Owners. Accordingly, the CRT was unable to conclude that any of these accounts belonged to the Claimed Account Owners.

## The CRT's Analysis

### Identification of the Account Owners

The list below contains names of account owners and/or power of attorney holders that match the names of the Claimed Account Owners and the reasons why the CRT has concluded that the Claimed Account Owners and an account owner/power of attorney holder are not the same person. If an account owner's place of residence was published, that place of residence is also listed.

*Name: Olga Meyer*

*Account Identification Number: 5035965*

*Specifically, the Claimant stated that her relative, Olga Meyer, resided in Germany and the United States. In contrast, the records show that the account owner resided in a different country*

*Name: A. Heine Meyer*

*Account Identification Number: 1001469*

*Specifically, the Claimant stated that her relatives, Anna Meyer and Adolf Meyer, resided in Germany and the United States. In contrast, the records show that the account owner resided in a different country.*

*Name: A. Meyer (power of attorney holder)*

*Account Identification Number: 5030488*

*Specifically, the Claimant is claiming the accounts of her relatives Anna Meyer or Adolf Meyer. In contrast, the records show that the power of attorney holder had a different first name. The CRT further notes that the Claimant did not identify the account owner.*

### Right of Appeal and Request for Reconsideration

Pursuant to Article 30 of the Rules Governing the Claims Resolution Process, as amended (the "Rules"), the Claimant may appeal this decision or submit a request for reconsideration within ninety (90) days of the date of the letter accompanying this decision.

An appeal must be based upon a plausible suggestion of error regarding the CRT's conclusions set out in this decision. Any appeals which are submitted without a plausible suggestion of error shall be summarily denied. A request for reconsideration must be based on new documentary evidence not previously presented to the CRT that, if considered, would have led to a different outcome of the claim. Claimants should briefly explain the relevance of the newly submitted documents in view of the conclusions stated in the certified decision.

### **Scope of the Denial**

The CRT now considers the Claimant's claim to the accounts of Olga Meyer, Adolf Meyer and Anna Meyer closed. Please note that this decision applies only to the Claim Number and Claimed Account Owners identified herein, and that the CRT is aware that the Claimant may have claimed accounts held by other persons or entities both in the Claim Number specified above and in other claims submitted to the CRT.

### **Certification of the Denial**

The CRT certifies this Denial for approval by the Court.
