Claimed Account Owner: Martha Neuron, née Berger¹

Claim Number: 789568/SB

This Certified Denial is to the claim of [REDACTED] (the “Claimant”) to a Swiss bank account potentially owned by the Claimant’s relative, Martha Neuron, née Berger (the “Claimed Account Owner”).

All denials are published, but where a claimant has requested confidentiality, as in this case, the names of the claimant, any relatives of the claimant other than the account owner, and the bank have been redacted.

Information Provided by the Claimant

The Claimant submitted a claim stating that Martha Neuron, née Berger, who was Jewish, was born on 8 April 1888 and resided in Vienna, Austria until 1938, when she fled Austria to the United States. The Claimant further stated that Martha Neuron died in April 1961 in Los Angeles, California, the United States.

The CRT’s Investigation

The CRT matched the name of Martha Neuron, née Berger to the names of all account owners in the Account History Database and identified accounts belonging to individuals whose names match, or are substantially similar to, the name of the Claimed Account Owner. In doing so, the CRT used advanced name matching systems and computer programs, and considered variations of names, including name variations provided by Yad Vashem, The Holocaust Martyrs’ and Heroes’ Remembrance Authority, in Jerusalem, Israel, to ensure that all possible name matches were identified. However, a close review of the relevant bank records indicated that the information contained therein was inconsistent with the information the Claimant provided regarding the Claimed Account Owner. Accordingly, the CRT was unable to conclude that any of these accounts belonged to the Claimed Account Owner.

Information Available Concerning the Account Owner

The CRT has located one account where an account owner's name matches the name of the Claimant's relative, Martha Neuron, née Berger. The list below contains details of the type of information held about an account owner. The account is identified by its Account Identification Number, which is a number assigned to the account for tracking purposes.

Account 5029357

The records indicate that the account owner was Marta Berger, who resided in Pilsen, Czechoslovakia, and that the power of attorney holder was Otto Berger. The records also indicate the name of the account owner's spouse and contain both the account owner's and the power of attorney holder's signatures.

The CRT's Analysis

Identification of the Account Owner

The CRT concludes that the Claimant has not identified the account owner as their relative. Although the name of the Claimant's relative matches the published name of the account owner, the CRT notes that the information provided by the Claimant differs materially from the information about the account owner contained in the records. Specifically, the Claimant stated that his relative, Martha Neuron, née Berger, resided in Austria and the United States. In contrast, the records show that the account owner resided in Czechoslovakia. The CRT also notes that the Claimant did not identify the account owner's spouse.

The Claimant should note that all accounts awarded by the CRT are published upon release on the CRT's website at www.crt-ii.org.

Right of Appeal and Request for Reconsideration

Pursuant to Article 30 of the Rules Governing the Claims Resolution Process, as amended (the "Rules"), the Claimant may appeal this decision or submit a request for reconsideration within ninety (90) days of the date of the letter accompanying this decision.

An appeal must be based upon a plausible suggestion of error regarding the CRT's conclusions set out in this decision. Any appeals which are submitted without a plausible suggestion of error shall be summarily denied. A request for reconsideration must be based on new documentary evidence not previously presented to the CRT that, if considered, would have led to a different outcome of the claim. Claimants should briefly explain the relevance of the newly submitted documents in view of the conclusions stated in the certified decision.

treated in this decision, the Claimant should identify the account, including, where available, the Account Identification Number, that forms the basis of the appeal and/or request for reconsideration.

Scope of the Denial

The CRT now considers the Claimant's claim to the accounts of Martha Neuron, née Berger, closed. Please note that this decision applies only to the Claim Number and Claimed Account Owner identified herein, and that the CRT is aware that the Claimant may have claimed accounts held by other persons or entities both in the Claim Number specified above and in other claims submitted to the CRT.

Certification of the Denial

The CRT certifies this Denial for approval by the Court.
