In re Holocaust Victim Assets Litigation  
Case No. CV96-4849

## **Certified Denial**

to Claimant [REDACTED]

**Claimed Account Owner: Joseph Pollack<sup>1</sup>**

Claim Number: 221781/HB

This Certified Denial is to the claim of [REDACTED], née [REDACTED] (the “Claimant”) to a Swiss bank account potentially owned by the Claimant’s relative, Joseph (Josef) Pollack (Pollak) (the “Claimed Account Owner”).

All denials are published, but where a claimant has requested confidentiality, as in this case, the names of the claimant, any relatives of the claimant other than the account owner, and the bank have been redacted.

### **Information Provided by the Claimant**

The Claimant submitted a claim stating that Joseph Pollack, who was Jewish, resided in Cluj, Romania (also known as Kolozsvár, Hungary before 1920 and between 1940 and 1945) in 1944, and in Arad, Romania. The Claimant did not indicate when exactly Joseph Pollak resided in Arad. The Claimant did not provide any further information or documentation regarding Joseph Pollak.

### **The CRT’s Investigation**

The CRT matched the name of Joseph (Josef) Pollack (Pollak) to the names of all account owners in the Account History Database and identified accounts belonging to individuals whose names match, or are substantially similar to, the name of the Claimed Account Owner. In doing so, the CRT used advanced name matching systems and computer programs, and considered variations of names, including name variations provided by Yad Vashem, The Holocaust Martyrs’ and Heroes’ Remembrance Authority, in Jerusalem, Israel, to ensure that all possible name matches were identified. However, a close review of the relevant bank records indicated that the information contained therein was inconsistent with the information the Claimant

provided regarding the Claimed Account Owner. Accordingly, the CRT was unable to conclude that any of these accounts belonged to the Claimed Account Owner.

## **The CRT's Analysis**

### Identification of the Account Owner

The list below contains names of account owners that match the name of the Claimed Account Owner and the reasons why the CRT has concluded that the Claimed Account Owner and an account owner are not the same person. If an account owner's place of residence was published, that place of residence is also listed.

*Name: Josef Pollak (Arad, Romania); Josef Pollak ( Arad, Hungary)*

*Account Identification Numbers: 4023273; 4019984*

*Specifically, the Claimant indicated that her relative, Joseph Pollack, resided in Cluj in 1944 and in Arad. In contrast, the bank records indicate that the account was held jointly with other individuals, whom the Claimant did not identify. The CRT notes that the accounts were awarded to other claimants who definitely identified the account owner and the joint account owners by identifying unpublished information about the account owners, including the connection to the joint account owners and the academic/professional title of one of the joint account owners.*

*Name: Josef Pollak (Germany)*

*Account Identification Number: 1009278*

*Specifically, the Claimant stated that her relative, Joseph Pollack, resided in Cluj, Romania (Kolozsvar, Hungary) and Arad, Romania. In contrast, the records show that the account owner resided in Germany.*

*Name: Josef Pollak (Vienna, Austria)*

*Account Identification Number: 4020420*

*Specifically, the Claimant stated that her relative, Joseph Pollack, resided in Cluj, Romania (Kolozsvar, Hungary) and Arad, Romania. In contrast, the records show that the account owner resided in Austria.*

The Claimant should note that all accounts awarded by the CRT are published upon release on the CRT's website at [www.crt-ii.org](http://www.crt-ii.org).

### Right of Appeal and Request for Reconsideration

Pursuant to Article 30 of the Rules Governing the Claims Resolution Process, as amended (the "Rules"), the Claimant may appeal this decision or submit a request for reconsideration within ninety (90) days of the date of the letter accompanying this decision.

An appeal must be based upon a plausible suggestion of error regarding the CRT's conclusions set out in this decision. Any appeals which are submitted without a plausible suggestion of error shall be summarily denied. A request for reconsideration must be based on new documentary

evidence not previously presented to the CRT that, if considered, would have led to a different outcome of the claim. Claimants should briefly explain the relevance of the newly submitted documents in view of the conclusions stated in the certified decision.

If more than one account has been treated in this decision, the Claimant should identify the account, including, where available, the Account Identification Number, that forms the basis of the appeal and/or request for reconsideration.

### **Scope of the Denial**

The CRT now considers the Claimant's claim to the accounts of Joseph Pollack closed. Please note that this decision applies only to the Claim Number and Claimed Account Owner identified herein, and that the CRT is aware that the Claimant may have claimed accounts held by other persons or entities both in the Claim Number specified above and in other claims submitted to the CRT.

### **Certification of the Denial**
