In re Holocaust Victim Assets Litigation  
Case No. CV96-4849

## **Certified Denial**

to Claimant Ruth Whitman

**Claimed Account Owners: Rosa Salzmann and Morris Salzmann<sup>1</sup>**

Claim Numbers: 214865/SB; 300449/SB

This Certified Denial is to the claims of Ruth Whitman (the “Claimant”) to a Swiss bank account potentially owned by the Claimant’s relatives, Rosa Salzmann (Salzman, Saltzman) and Morris (Moshe) Salzmann (Salzman, Saltzman) (the “Claimed Account Owners”).

All denials are published. Where a claimant has not requested confidentiality, as in this case, only the name of the bank has been redacted.

### **Information Provided by the Claimant**

The Claimant submitted claims stating that Rosa Salzmann and Morris Salzmann, who were Jewish, resided in Austria. The Claimant further stated that members of the Salzmann family resided in Rimolof and Trembowla, Austria and, in subsequent correspondence, the Claimant stated that Rosa Salzmann’s maiden name was Rosa Ronis.

### **The CRT’s Investigation**

The CRT matched the names of Rosa Salzmann (Salzman, Saltzman) and Morris (Moshe) Salzmann (Salzman, Saltzman) to the names of all account owners and power of attorney holders in the Account History Database and identified accounts belonging to individuals whose names match, or are substantially similar to, the name of the Claimed Account Owners. In doing so, the CRT used advanced name matching systems and computer programs, and considered variations of names, including name variations provided by Yad Vashem, The Holocaust Martyrs’ and Heroes’ Remembrance Authority, in Jerusalem, Israel, to ensure that all possible name matches were identified. However, a close review of the relevant bank records indicated that the information contained therein was inconsistent with the information the Claimant provided regarding the Claimed Account Owners. Accordingly, the CRT was unable to conclude that any of these accounts belonged to the Claimed Account Owners.

## **The CRT's Analysis**

### Identification of the Account Owner

The list below contains names of account owners and power of attorney holders that match the names of the Claimed Account Owners and the reasons why the CRT has concluded that the Claimed Account Owners and an account owner, or power of attorney holder, are not the same person. If an account owner's place of residence was published, that place of residence is also listed.

*Name: Rosa Salzmann (Vienna, Austria), Moritz Salzmann (power of attorney holder)*

*Account Identification Number: 5024235*

*Specifically, the Claimant stated that her relative, Rosa Salzmann, had the maiden name Rosa Ronis. In contrast, the records show that the account owner had a different maiden name. The CRT further notes that the Claimant stated that the Salzmann family resided in Rimolof and Trembowla, Austria, whereas the records show that the power of attorney holder resided in a different city.*

### Right of Appeal and Request for Reconsideration

Pursuant to Article 30 of the Rules Governing the Claims Resolution Process, as amended (the "Rules"), the Claimant may appeal this decision or submit a request for reconsideration within ninety (90) days of the date of the letter accompanying this decision.

An appeal must be based upon a plausible suggestion of error regarding the CRT's conclusions set out in this decision. Any appeals which are submitted without a plausible suggestion of error shall be summarily denied. A request for reconsideration must be based on new documentary evidence not previously presented to the CRT that, if considered, would have led to a different outcome of the claim. Claimants should briefly explain the relevance of the newly submitted documents in view of the conclusions stated in the certified decision.

If more than one account has been treated in this decision, the Claimant should identify the account, including, where available, the Account Identification Number, that forms the basis of the appeal and/or request for reconsideration.

### **Scope of the Denial**

The CRT now considers the Claimant's claims to the accounts of Rosa Salzmann and Morris Salzmann closed. Please note that this decision applies only to the Claim Numbers and Claimed

Account Owners identified herein, and that the CRT is aware that the Claimant may have claimed accounts held by other persons or entities both in the Claim Numbers specified above and in other claims submitted to the CRT.
