In re Holocaust Victim Assets Litigation  
Case No. CV96-4849

## **Certified Denial**

to Claimant Friedrich Schubert

**Claimed Account Owner: Friedrich Schubert<sup>1</sup>**

Claim Number: 207181/RT

This Certified Denial is to the claim of Friedrich Schubert (the “Claimant”) to Swiss bank accounts potentially owned by the Claimant’s relative, Friedrich Schubert, and the Claimant himself (the “Claimed Account Owners”).

All denials are published, but where a claimant has requested confidentiality, as in this case, the names of the claimant, any relatives of the claimant other than the account owner, and the bank have been redacted.

### **Information Provided by the Claimant**

The Claimant submitted a claim stating that his father Friedrich Schubert, who was Sinti, resided in Germany. The Claimant further stated that he also is Sinti and that he resided in Germany.

### **The CRT’s Investigation**

The CRT matched the name of Friedrich Schubert to the names of all account owners in the Account History Database and identified accounts belonging to individuals whose names match, or are substantially similar to, the name of the Claimed Account Owner. In doing so, the CRT used advanced name matching systems and computer programs, and considered variations of names, including name variations provided by Yad Vashem, The Holocaust Martyrs’ and Heroes’ Remembrance Authority, in Jerusalem, Israel, to ensure that all possible name matches were identified. However, a close review of the relevant bank records indicated that the information contained therein was inconsistent with the information the Claimant provided regarding the Claimed Account Owner. Accordingly, the CRT was unable to conclude that any of these accounts belonged to the Claimed Account Owner.

## The CRT's Analysis

### Identification of the Account Owner

The list below contains names of account owners that match the name of the Claimed Account Owners and the reasons why the CRT has concluded that the Claimed Account Owners and an account owner are not the same person. If an account owner's place of residence was published, that place of residence is also listed.

*Name: Friedrich Schubert (Vienna, Austria)*

*Account Identification Number: 5033622*

*Specifically, the Claimant stated that he and his father, who were both named Friedrich Schubert, resided in Germany. The Claimant further stated that he was born in 1927. In contrast, the records show that the account owner resided in Austria. The records further contain a bank document signed by the account owner at a time when the Claimant was a minor and not legally able to sign such a document. The CRT also notes that the Claimant did not identify the power of attorney holder, who appears to have been closely related to the account owner.*

### Right of Appeal and Request for Reconsideration

Pursuant to Article 30 of the Rules Governing the Claims Resolution Process, as amended (the "Rules"), the Claimant may appeal this decision or submit a request for reconsideration within ninety (90) days of the date of the letter accompanying this decision.

An appeal must be based upon a plausible suggestion of error regarding the CRT's conclusions set out in this decision. Any appeals which are submitted without a plausible suggestion of error shall be summarily denied. A request for reconsideration must be based on new documentary evidence not previously presented to the CRT that, if considered, would have led to a different outcome of the claim. Claimants should briefly explain the relevance of the newly submitted documents in view of the conclusions stated in the certified decision.

If more than one account has been treated in this decision, the Claimant should identify the account, including, where available, the Account Identification Number, that forms the basis of the appeal and/or request for reconsideration.

**Scope of the Denial**

The CRT now considers the Claimant's claim to the accounts of Friedrich Schubert closed. Please note that this decision applies only to the Claim Number and Claimed Account Owners identified herein, and that the CRT is aware that the Claimant may have claimed accounts held by other persons or entities both in the Claim Number specified above and in other claims submitted to the CRT.
