In re Holocaust Victim Assets Litigation  
Case No. CV96-4849

## **Certified Denial**

to Claimant Ferenc Schwartz

**Claimed Account Owners: Margareta Schwartz and Arthur Schwartz<sup>1</sup>**

Claim Number: 203481/RT

This Certified Denial is to the claim of Ferenc Schwartz (the “Claimant”) to Swiss bank accounts potentially owned by the Claimant’s parents, Margareta (Margit) Schwartz (Pollak) and Arthur Schwartz (the “Claimed Account Owners”).

All denials are published. Where a claimant has not requested confidentiality, as in this case, only the name of the bank has been redacted.

### **Information Provided by the Claimant**

The Claimant submitted a claim stating that Margareta Schwartz and Arthur Schwartz, who were Jewish, resided in Oradea, Romania (Nagyvarad, Hungary before 1920 and between 1940 and 1944). The Claimant further stated that his mother’s maiden name was Pollak.

### **The CRT’s Investigation**

The CRT matched the names of Margareta (Margit) Schwartz (Pollak) and Arthur Schwartz to the names of all account owners in the Account History Database and identified accounts belonging to individuals whose names match, or are substantially similar to, the name of the Claimed Account Owners. In doing so, the CRT used advanced name matching systems and computer programs, and considered variations of names, including name variations provided by Yad Vashem, The Holocaust Martyrs’ and Heroes’ Remembrance Authority, in Jerusalem, Israel, to ensure that all possible name matches were identified. However, a close review of the relevant bank records indicated that the information contained therein was inconsistent with the information the Claimant provided regarding the Claimed Account Owners. Accordingly, the CRT was unable to conclude that any of these accounts belonged to the Claimed Account Owners.

## The CRT's Analysis

### Identification of the Account Owners

The list below contains names of account owners that match the names of the Claimed Account Owners and the reasons why the CRT has concluded that the Claimed Account Owners and an account owner are not the same person. If an account owner's place of residence was published, that place of residence is also listed.

*Name: M. Schwarz (Säckingen, Germany)*

*Account Identification Number: 1013699*

*Specifically, the Claimant stated that his mother, Margareta Schwartz, resided in Oradea, Romania (Nagyvarad, Hungary). In contrast, the records show that the account owner resided in Germany.*

*Name: M. Schwarz*

*Account Identification Number: 6002108*

*Specifically, the Claimant stated that Margareta Schwartz was his mother. In contrast, the records show that the account owner was male.*

*Name: M. J. Pollak (Paris, France)*

*Account Identification Number: 5031149*

*Specifically, the Claimant stated that his mother, Margareta Schwartz, resided in Oradea, Romania (Nagyvarad, Hungary). In contrast, the records show that the account owner resided in France.*

*Name: Frl. Margit Pollak (AKA Frau Margit Tintner, Vienna, Austria)*

*Account Identification Numbers: 5026793; 5029919*

*Specifically, the Claimant stated that his mother, Margareta Schwartz, resided in Oradea, Romania (Nagyvarad, Hungary). In contrast, the records show that the account owner resided in Austria.*

*Name: Margrit Pollak (Maisons-Alfort, France)*

*Account Identification Number: 5030387*

*Specifically, the Claimant stated that his mother, Margareta Schwartz, resided in Oradea, Romania (Nagyvarad, Hungary). In contrast, the records show that the account owner resided in France.*

*Name: A. Schwarz (Germany)*

*Account Identification Number: 1011299*

*Specifically, the Claimant stated that his father, Arthur Schwartz, resided in Oradea, Romania (Nagyvarad, Hungary). In contrast, the records show that the account owner resided in Germany.*

*Name: Arthur Schwarz (Berlin, Germany)*

*Account Identification Number: 4019951*

*Specifically, the Claimant stated that his father, Arthur Schwartz, resided in Oradea, Romania (Nagyvarad, Hungary). In contrast, the records show that the account owner resided in Germany.*

The Claimant should note that all accounts awarded by the CRT are published upon release on the CRT's website at [www.crt-ii.org](http://www.crt-ii.org).

### Right of Appeal and Request for Reconsideration

Pursuant to Article 30 of the Rules Governing the Claims Resolution Process, as amended (the "Rules"), the Claimant may appeal this decision or submit a request for reconsideration within ninety (90) days of the date of the letter accompanying this decision.

An appeal must be based upon a plausible suggestion of error regarding the CRT's conclusions set out in this decision. Any appeals which are submitted without a plausible suggestion of error shall be summarily denied. A request for reconsideration must be based on new documentary evidence not previously presented to the CRT that, if considered, would have led to a different outcome of the claim. Claimants should briefly explain the relevance of the newly submitted documents in view of the conclusions stated in the certified decision.

If more than one account has been treated in this decision, the Claimant should identify the account, including, where available, the Account Identification Number, that forms the basis of the appeal and/or request for reconsideration.

### **Scope of the Denial**

The CRT now considers the Claimant's claim to the accounts of Marareta Schwartz and Arthur Schwartz closed. Please note that this decision applies only to the Claim Number and Claimed Account Owners identified herein, and that the CRT is aware that the Claimant may have claimed accounts held by other persons or entities both in the Claim Number specified above and in other claims submitted to the CRT.
