## **Certified Denial**

to Claimant [REDACTED]

**Claimed Account Owners: Bedrich Urbach and Marketa Urbach<sup>1</sup>**

Claim Numbers: 214535/SB; 214536/SB

This Certified Denial is to the claims of [REDACTED] (the “Claimant”) to the Swiss bank account over which Bedrich Thias and Marketa Thiasova held power of attorney, as published on the February 2001 published list of accounts determined by Independent Committee of Eminent Persons (“ICEP”) to be probably or possibly those of Victims of Nazi Persecution (the “ICEP List”) and potentially owned by the Claimant’s relatives, Bedrich Urbach and Marketa Urbach (the “Claimed Account Owners”).

All denials are published, but where a claimant has requested confidentiality, as in this case, the names of the claimant, any relatives of the claimant other than the account owner, and the bank have been redacted.

### **Information Provided by the Claimant**

The Claimant submitted claims stating that her relatives’ full names, who were Jewish, were Bedrich Thias Urbach and Marketa (Marianna) Urbach. In support of her claims the Claimant provided a printout from the Theresienstadt Martyrs Remembrance Association, which records the Claimant’s relatives’ names as Bedrich Urbach and Marketa Urbach.

### **The CRT’s Investigation**

The CRT matched the names of Bedrich Thias Urbach and Marketa (Marianna) Urbach to the names of all account owners and power of attorney holders in the Account History Database and identified accounts belonging to individuals whose names match, or are substantially similar to, the name of the Claimed Account Owners. In doing so, the CRT used advanced name matching systems and computer programs, and considered variations of names, including name variations provided by Yad Vashem, The Holocaust Martyrs’ and Heroes’ Remembrance Authority, in Jerusalem, Israel, to ensure that all possible name matches were identified. However, a close review of the relevant bank records indicated that the information contained therein was

inconsistent with the information the Claimant provided regarding the Claimed Account Owners. Accordingly, the CRT was unable to conclude that any of these accounts belonged to the Claimed Account Owners.

## **The CRT's Analysis**

### Identification of the Account Owners

The list below contains names of account owners and power of attorney holders that match the names of the Claimed Account Owners and the reasons why the CRT has concluded that the Claimed Account Owners and an account owner, or power of attorney holder, are not the same person. If an account owner's place of residence was published, that place of residence is also listed.

*Name: Bedrich Thias and Marianna Thiasova*

*Account Identification Number: 50269559*

*Specifically, the Claimant stated that her relative's full names were Bedrich Urbach and Marketa Urbach. In contrast, the records show that the power of attorney holders' full names were Bedrich Thias and Marianna Thiasova. The CRT also notes that the records contains the power of attorney holders' signatures and that there is nothing in the records to indicate that these are false names or pseudonyms.*

*In addition, the CRT notes that the Claimant did not identify the account owner, Jean Urbach, and that under Swiss law, a power of attorney holder is not considered to be the owner of an account. After a power of attorney holder dies, his or her powers in an account no longer exist, and they do not pass to his or her heirs. Therefore, even if the Claimant had identified the power of attorney holder, but not the account owner, as their relative, the Claimant would not have been entitled to the account unless there was evidence in the bank's records that the power of attorney holder and the account owner were related.*

### Right of Appeal and Request for Reconsideration

Pursuant to Article 30 of the Rules Governing the Claims Resolution Process, as amended (the "Rules"), the Claimant may appeal this decision or submit a request for reconsideration within ninety (90) days of the date of the letter accompanying this decision.

An appeal must be based upon a plausible suggestion of error regarding the CRT's conclusions set out in this decision. Any appeals which are submitted without a plausible suggestion of error shall be summarily denied. A request for reconsideration must be based on new documentary evidence not previously presented to the CRT that, if considered, would have led to a different outcome of the claim. Claimants should briefly explain the relevance of the newly submitted documents in view of the conclusions stated in the certified decision.

If more than one account has been treated in this decision, the Claimant should identify the account, including, where available, the Account Identification Number, that forms the basis of the appeal and/or request for reconsideration.

### **Scope of the Denial**

The CRT now considers the Claimant's claim to the accounts of Bedrich Urbach and Marketa Urbach closed. Please note that this decision applies only to the Claim Number and Claimed Account Owners identified herein, and that the CRT is aware that the Claimant may have claimed accounts held by other persons or entities both in the Claim Number specified above and in other claims submitted to the CRT.

### **Certification of the Denial**

The CRT certifies this Denial for approval by the Court.
