In re Holocaust Victim Assets Litigation
Case No. CV96-4849

Certified Denial

to Claimant Annie Wolf

Claimed Account Owners: Willy Vogel and Annie Vogel¹

Claim Number: 209879/SB

This Certified Denial is to the claim of Annie Wolf (the “Claimant”) to a Swiss bank account potentially owned by the Claimant’s relative, Willy (Wilhelm) Vogel and the Claimant, Annie Wolf, née Vogel (the “Claimed Account Owners”).

All denials are published, but where a claimant has requested confidentiality, as in this case, the names of the claimant, any relatives of the claimant other than the account owner, and the bank have been redacted.

Information Provided by the Claimant

The Claimant submitted a claim stating that Willy Vogel, who was Jewish, resided in Kirn and Saarbrücken, Germany, until 1934, when he fled to Luxembourg, then France, and that he ultimately emigrated to the United States in 1941. The Claimant further stated that she was born in 1923.

The CRT’s Investigation

The CRT matched the names of Willy (Wilhelm) Vogel and Annie Vogel to the names of all account owners in the Account History Database and identified accounts belonging to individuals whose names match, or are substantially similar to, the name of the Claimed Account Owners. In doing so, the CRT used advanced name matching systems and computer programs, and considered variations of names, including name variations provided by Yad Vashem, The Holocaust Martyrs’ and Heroes’ Remembrance Authority, in Jerusalem, Israel, to ensure that all possible name matches were identified. However, a close review of the relevant bank records indicated that the information contained therein was inconsistent with the information the Claimant provided regarding the Claimed Account Owners. Accordingly, the CRT was unable to conclude that any of these accounts belonged to the Claimed Account Owners.

¹ The Claimant should note that this determination relates only to the Claim Number and Claimed Account Owners stated above, and that the CRT is aware that the Claimant may have submitted other claims.

The CRT's Analysis

Identification of the Account Owners

The list below contains names of account owners that match the names of the Claimed Account Owners and the reasons why the CRT has concluded that the Claimed Account Owners and an account owner are not the same person. If an account owner's place of residence was published, that place of residence is also listed.

Name: Wilhelm Vogel (Emmendingen, Germany)

Account Identification Number: 5027667

Specifically, the Claimant stated that her relative, Willy Vogel, resided in Kirn and Saarbrücken, Germany. In contrast, the records show that the account owner resided in Emmendingen, Germany, which is over 150 kilometers from Kirn and Saarbrücken. The CRT notes that there are other cities significantly closer to Kirn and Saarbrücken than Emmendingen, thus rendering it unlikely that a resident of Kirn and Saarbrücken would indicate Emmendingen as their place of residence, even for the purposes of maintaining a Swiss bank account.

Name: Anna Vogel (Germany)

Account Identification Numbers: 1014086 and 1014087

Specifically, the Claimant stated that she, Annie Vogel, was born in 1923. In contrast, the records show that the account owner had a professional or academic title at a time when the Claimant was still a young child.

The Claimant should note that all accounts awarded by the CRT are published upon release on the CRT's website at www.crt-ii.org.

Right of Appeal and Request for Reconsideration

Pursuant to Article 30 of the Rules Governing the Claims Resolution Process, as amended (the "Rules"), the Claimant may appeal this decision or submit a request for reconsideration within ninety (90) days of the date of the letter accompanying this decision.

An appeal must be based upon a plausible suggestion of error regarding the CRT's conclusions set out in this decision. Any appeals which are submitted without a plausible suggestion of error shall be summarily denied. A request for reconsideration must be based on new documentary evidence not previously presented to the CRT that, if considered, would have led to a different outcome of the claim. Claimants should briefly explain the relevance of the newly submitted documents in view of the conclusions stated in the certified decision.

If more than one account has been treated in this decision, the Claimant should identify the account, including, where available, the Account Identification Number, that forms the basis of the appeal and/or request for reconsideration.

Scope of the Denial

The CRT now considers the Claimant's claim to the accounts of Willy Vogel and Annie Vogel closed. Please note that this decision applies only to the Claim Number and Claimed Account Owners identified herein, and that the CRT is aware that the Claimant may have claimed accounts held by other persons or entities both in the Claim Number specified above and in other claims submitted to the CRT.
