In re Holocaust Victim Assets Litigation
Case No. CV96-4849

Certified Denial

to Claimant Berthe Muiron

Claimed Account Owner: Berthe Wahl¹

Claim Number: 213744/SU

This Certified Denial is to the claim of Berthe Muiron, née Wahl (the “Claimant”) to a Swiss bank account potentially owned by the Claimant, herself, Berthe Wahl (the “Claimed Account Owner”).

All denials are published, but where a claimant has requested confidentiality, as in this case, the names of the claimant, any relatives of the claimant other than the account owner, and the bank have been redacted.

Information Provided by the Claimant

The Claimant submitted a claim completed by her son, [REDACTED], stating that she, Berthe Wahl, who was Jewish, was born on 18 December 1911, in Meurthe et Moselle, Nancy, France. The Claimant further stated that on 10 July 1932, she married [REDACTED] in Enghien-Les-Bains, France, and that the couple divorced on 19 July 1948. The Claimant also stated that in 1950, she remarried and took her husband’s name, Muiron.

The CRT’s Investigation

The CRT matched the name of Berthe Wahl to the names of all account owners in the Account History Database and identified accounts belonging to individuals whose names match, or are substantially similar to, the name of the Claimed Account Owner. In doing so, the CRT used advanced name matching systems and computer programs, and considered variations of names, including name variations provided by Yad Vashem, The Holocaust Martyrs’ and Heroes’ Remembrance Authority, in Jerusalem, Israel, to ensure that all possible name matches were identified. However, a close review of the relevant bank records indicated that the information contained therein was inconsistent with the information the Claimant provided regarding the Claimed Account Owner. Accordingly, the CRT was unable to conclude that any of these accounts belonged to the Claimed Account Owner.

¹ The Claimant should note that this determination relates only to the Claim Number and Claimed Account Owner stated above, and that the CRT is aware that the Claimant may have submitted other claims.

The CRT's Analysis

Identification of the Account Owner

The list below contains names of account owners that match the name of the Claimed Account Owner and the reasons why the CRT has concluded that the Claimed Account Owner and an account owner are not the same person. If an account owner's place of residence was published, that place of residence is also listed.

Name: Mme. Berthe Wahl

Account Identification Number: 4022864

Specifically, the Claimant stated that she, Berthe Wahl, married [REDACTED] on 19 July 1932 and that Wahl was her maiden name. In contrast, the bank records show that Wahl was the account owner's married name.

The Claimant should note that all accounts awarded by the CRT are published upon release on the CRT's website at www.crt-ii.org.

Right of Appeal and Request for Reconsideration

Pursuant to Article 30 of the Rules, the Claimant may appeal this decision or submit a request for reconsideration within ninety (90) days of the date of the letter accompanying this decision.

An appeal must be based upon a plausible suggestion of error regarding the CRT's conclusions set out in this decision. Any appeals which are submitted without a plausible suggestion of error shall be summarily denied. A request for reconsideration must be based on new documentary evidence not previously presented to the CRT that, if considered, would have led to a different outcome of the claim. Claimants should briefly explain the relevance of the newly submitted documents in view of the conclusions stated in the certified decision.

If more than one account has been treated in this decision, the Claimant should identify the account, including, where available, the Account Identification Number, that forms the basis of the appeal and/or request for reconsideration.

Scope of the Denial

The CRT now considers the Claimant's claim to the accounts of Berthe Wahl closed. Please note that this decision applies only to the Claim Number and Claimed Account Owner identified herein, and that the CRT is aware that the Claimant may have claimed accounts held by other persons or entities both in the Claim Number specified above and in other claims submitted to the CRT.

Certification of the Denial

The CRT certifies this Denial for approval by the Court.
