In re Holocaust Victim Assets Litigation  
Case No. CV96-4849

## **Certified Denial**

to Claimant [REDACTED]

**Claimed Account Owners: Ferenc Weiss, Adolf Weiss and Jacob Weiss<sup>1</sup>**

Claim Number: 711603/MG

This determination is based on the claim of [REDACTED] (the “Claimant”) to a Swiss bank account potentially owned by Ferenc Weiss, Adolf Weiss and Jacob Weiss. The CRT did not locate an account belonging to Jacob (Jakob) Weiss in the Account History Database prepared pursuant to the investigation of the Independent Committee of Eminent Persons (“ICEP” or “ICEP Investigation”), which identified accounts probably or possibly belonging to Victims of Nazi Persecution, as defined in the Rules Governing the Claims Resolution Process, as amended (the “Rules”).

This Certified Denial is to a Swiss bank account potentially owned by the Claimant’s relatives, Ferenc Weiss and Adolf Weiss (the “Claimed Account Owners”).

All denials are published, but where a claimant has requested confidentiality, as in this case, the names of the claimant, any relatives of the claimant other than the account owner, and the bank have been redacted.

### **Information Provided by the Claimant**

The Claimant submitted a claim stating that his relatives, Ferenc and Adolf Weiss, who were Jewish, resided in Hungary and Romania.

### **The CRT’s Investigation**

The CRT matched the names of Ferenc Weiss and Adolf Weiss to the names of all account owners in the Account History Database and identified accounts belonging to individuals whose names match, or are substantially similar to, the name of the Claimed Account Owners. In doing so, the CRT used advanced name matching systems and computer programs, and considered variations of names, including name variations provided by Yad Vashem, The Holocaust

Martyrs' and Heroes' Remembrance Authority, in Jerusalem, Israel, to ensure that all possible name matches were identified. However, a close review of the relevant bank records indicated that the information contained therein was inconsistent with the information the Claimant provided regarding the Claimed Account Owners. Accordingly, the CRT was unable to conclude that any of these accounts belonged to the Claimed Account Owners.

## **The CRT's Analysis**

### Identification of the Account Owners

The list below contains names of account owners that match the names of the Claimed Account Owners and the reasons why the CRT has concluded that the Claimed Account Owners and an account owner are not the same person. If an account owner's place of residence was published, that place of residence is also listed.

*Name: Franz Karl Weiss (Hungary)*

*Account Identification Number: 1000423*

*Specifically, the Claimant is claiming the account of his relative Ferenc Weiss.<sup>2</sup> The CRT notes that the account at issue was awarded to another claimant who plausibly identified the account owner as his relative, including identifying the account owner's first and middle names as specified in the bank's records.*

*Name: Franz Xavier Weiss*

*Account Identification Numbers: 4019681; 5027658*

*Specifically, the Claimant stated that his relative, Ferenc Weiss, resided in Hungary and Romania. In contrast, the records show that the account owner resided in a different country.*

*Name: Adolf Weiss*

*Account Identification Numbers: 1014449; 1014450*

*Specifically, the Claimant stated that his relative, Adolf Weiss, resided in Romania and Hungary. In contrast, the records show that the account owner resided in a different country.*

*Name: A. Weiss*

*Account Identification Numbers: 5030495; 5035927*

*Specifically, the Claimant stated that his relative, Adolf Weiss, resided in Romania and Hungary. In contrast, the records show that the account owner resided in a different country.*

The CRT has taken utmost care in matching the names of the person identified by the Claimant as a possible account owner to names of actual account owners identified in the Account History Database prepared pursuant to the investigation of the Independent Committee of Eminent Persons ("ICEP" or "ICEP Investigation"), which identified accounts probably or possibly belonging to Victims of Nazi Persecution, as defined in the Rules Governing the Claims Resolution Process, as amended (the "Rules"). The CRT has reviewed this claim carefully and

analyzed matches to accounts belonging to account owners with alternative spellings of Ferenc Weiss's last name, which include Weisz, and has determined that these accounts did not belong to the Claimed Account Owner.

#### Right of Appeal and Request for Reconsideration

Pursuant to Article 30 of the Rules Governing the Claims Resolution Process, as amended (the "Rules"), the Claimant may appeal this decision or submit a request for reconsideration within ninety (90) days of the date of the letter accompanying this decision.

An appeal must be based upon a plausible suggestion of error regarding the CRT's conclusions set out in this decision. Any appeals which are submitted without a plausible suggestion of error shall be summarily denied. A request for reconsideration must be based on new documentary evidence not previously presented to the CRT that, if considered, would have led to a different outcome of the claim. Claimants should briefly explain the relevance of the newly submitted documents in view of the conclusions stated in the certified decision.

If more than one account has been treated in this decision, the Claimant should identify the account, including, where available, the Account Identification Number, that forms the basis of the appeal and/or request for reconsideration.

#### **Scope of the Denial**

The CRT now considers the Claimant's claim to the accounts of Ferenc Weiss, Adolf Weiss and Jacob Weiss closed. Please note that this decision applies only to the Claim Number and Claimed Account Owners identified herein, and that the CRT is aware that the Claimant may have claimed accounts held by other persons or entities both in the Claim Number specified above and in other claims submitted to the CRT.

#### **Certification of the Denial**

The CRT certifies this Denial for approval by the Court.
