In re Holocaust Victim Assets Litigation

Certified Denial

to Claimant [REDACTED]

Claimed Account Owner: Otto Wolff¹

Claim Number: 215701/RT

This Certified Denial is to the claim of [REDACTED] (the “Claimant”) to a Swiss bank account potentially owned by the Claimant’s relative, Otto (Ernst) Wolff (Wolf) (the “Claimed Account Owner”).

All denials are published, but where a claimant has requested confidentiality, as in this case, the names of the claimant, any relatives of the claimant other than the account owner, and the bank have been redacted.

Information Provided by the Claimant

The Claimant submitted a claim stating that Otto Wolff, who was Jewish, was a merchant who resided in Düren, Germany. The Claimant further stated that Otto Wolff may have been the brother or son of the Claimant’s great-uncle and that he may have had a business address in Cologne, Germany between 1940 and 1943. The Claimant also stated that Otto Wolff may have fled Germany for Prerov, Czechoslovakia (now Czech Republic) in 1944. The Claimant did not indicate any academic or professional title held by his relative. The Claimant did not provide any further information or documentation regarding Otto Wolff.

The CRT’s Investigation

The CRT matched the name of Otto (Ernst) Wolff (Wolf) to the names of all account owners in the Account History Database and identified accounts belonging to individuals whose names match, or are substantially similar to, the name of the Claimed Account Owner. In doing so, the CRT used advanced name matching systems and computer programs, and considered variations of names, including name variations provided by Yad Vashem, The Holocaust Martyrs’ and Heroes’ Remembrance Authority, in Jerusalem, Israel, to ensure that all possible name matches were identified. However, a close review of the relevant bank records indicated that the information contained therein was inconsistent with the information the Claimant provided

regarding the Claimed Account Owner. Accordingly, the CRT was unable to conclude that any of these accounts belonged to the Claimed Account Owner.

The CRT's Analysis

Identification of the Account Owner

The list below contains names of account owners that match the name of the Claimed Account Owner and the reasons why the CRT has concluded that the Claimed Account Owner and an account owner are not the same person. If an account owner's place of residence was published, that place of residence is also listed.

Name: Otto Wolf (Germany)

Account Identification Number: 2016796

Specifically, the Claimant stated that his relative, Otto Wolff, resided in Düren and may have had a business address in Cologne. In contrast, the records show that the account owner resided in a different city, which is over 500 kilometers from Düren and Cologne. The CRT notes that the Claimant did not identify the power of attorney holder.

Name: Otto Wolff (Germany)

Account Identification Number: 1000638

Specifically, the Claimant stated that his relative, Otto Wolff, was a merchant who resided in Düren and may have had a business address in Cologne. The Claimant did not indicate any academic or professional title held by his relative. In contrast, the records show that the account owner held such a title, which is inconsistent with the Claimant's relative's profession as a merchant. The records further show that the account owner resided in a different city, which is over 400 kilometers from Düren and Cologne.

Name: Otto Wolff (Katzenelnbogen, Germany)

Account Identification Numbers: 1014293; 1014294; 1014295; 1014296; 1014297; 1014298

Specifically, the Claimant stated that his relative, Otto Wolff, was a merchant, who resided in Düren and may have had a business address in Cologne. The Claimant did not indicate any academic or professional title held by his relative. In contrast, the records show that the account owner held such a title, which is inconsistent with the Claimant's relative's profession as a merchant. The records further show that the account owner resided Katzenelnbogen, which is over 150 kilometers from Düren and Cologne, and in an additional city, which was not identified by the Claimant and which is over 500 kilometers from Düren and Cologne.

Name: Otto Wolff (Cologne, Germany)

Account Identification Numbers: 4019477; 4019478; 4019479

Specifically, the Claimant stated that his relative, Otto Wolff, was a merchant, who resided in Düren and may have had a business address in Cologne. The Claimant did not provide any further information or documentation regarding Otto Wolff. In contrast, the records show that the account owner was a company, which the Claimant did not identify, and which did business inconsistent with the Claimant's relative's profession as a merchant.

Name: Otto Wolff (Vienna, Austria)

Account Identification Number: 5031008

Specifically, the Claimant stated that his relative, Otto Wolff, resided in Germany and may have fled Germany for Czechoslovakia in 1944. In contrast, the records show that the account owner resided in Austria.

The Claimant should note that all accounts awarded by the CRT are published upon release on the CRT's website at www.crt-ii.org.

Right of Appeal and Request for Reconsideration

Pursuant to Article 30 of the Rules Governing the Claims Resolution Process, as amended (the "Rules"), the Claimant may appeal this decision or submit a request for reconsideration within ninety (90) days of the date of the letter accompanying this decision.

An appeal must be based upon a plausible suggestion of error regarding the CRT's conclusions set out in this decision. Any appeals which are submitted without a plausible suggestion of error shall be summarily denied. A request for reconsideration must be based on new documentary evidence not previously presented to the CRT that, if considered, would have led to a different outcome of the claim. Claimants should briefly explain the relevance of the newly submitted documents in view of the conclusions stated in the certified decision.

If more than one account has been treated in this decision, the Claimant should identify the account, including, where available, the Account Identification Number, that forms the basis of the appeal and/or request for reconsideration.

Scope of the Denial

The CRT now considers the Claimant's claim to the accounts of Otto Wolff closed. Please note that this decision applies only to the Claim Number and Claimed Account Owner identified herein, and that the CRT is aware that the Claimant may have claimed accounts held by other persons or entities both in the Claim Number specified above and in other claims submitted to the CRT.
