In re Holocaust Victim Assets Litigation
Case No. CV96-4849

Certified Denial

to Claimant Ruth Elizabeth Lynn

Claimed Account Owner: Erich Rogowski¹

Claim Number: 402193/HU

This Certified Denial is to the claim of Ruth Elizabeth Lynn (the “Claimant”) to a Swiss bank account published on the list of power of attorney holders in 2005 and potentially owned by the Claimant’s relative, Erich Rogowski (the “Claimed Account Owner”).

All denials are published. Where a claimant has not requested confidentiality, as in this case, only the name of the bank has been redacted.

Information Provided by the Claimant

The Claimant submitted a claim stating that Erich Rogowski, who was Jewish, resided in Berlin, Germany, and Gresen and Posen, Poland (today, Gniezno and Poznań, Poland, respectively).

The CRT’s Investigation

The CRT matched the name of Erich Rogowski to the names of all account owners and power of attorney holders in the Account History Database and identified accounts belonging to individuals whose names match, or are substantially similar to, the name of the Claimed Account Owner. In doing so, the CRT used advanced name matching systems and computer programs, and considered variations of names, including name variations provided by Yad Vashem, The Holocaust Martyrs’ and Heroes’ Remembrance Authority, in Jerusalem, Israel, to ensure that all possible name matches were identified. However, a close review of the relevant bank records indicated that the information contained therein was inconsistent with the information the Claimant provided regarding the Claimed Account Owner. Accordingly, the CRT was unable to conclude that any of these accounts belonged to the Claimed Account Owner.

¹ The Claimant should note that this determination relates only to the Claim Number and Claimed Account Owner stated above, and that the CRT is aware that the Claimant may have submitted other claims.

The CRT's Analysis

Identification of the Account Owner

The list below contains names of account owner and/or power of attorney holder that match the names of the Claimed Account Owner and the reasons why the CRT has concluded that the Claimed Account Owner and an account owner or power of attorney holder are not the same person. If an account owner's place of residence was published, that place of residence is also listed.

Name: Erich Rogowski (Power of Attorney Holder)

Account Identification Number: 5030208

Specifically, the Claimant stated that her relative, Erich Rogowski, resided in Berlin, Germany, and Gresen and Posen, Poland (today Gniezno and Poznań, Poland, respectively). In contrast, the records show that the power of attorney holder resided in a different city in Poland, which is over 300 kilometers from Poznań, and over 250 kilometers from Gniezno. The CRT notes that Poznań and Gniezno are small towns, whereas the power of attorney holder resided in a major city and that there are several other major cities significantly closer to Poznań and Gniezno than the power of attorney's city of residence, thus rendering it unlikely that the Claimant's relative would indicate the power of attorney's city of residence as his place of residence, even for the purposes of maintaining a Swiss bank account. The CRT further notes that the Claimant did not identify the power of attorney's academic or professional title. In addition, the CRT notes that the Claimant did not identify the account owner.

The Claimant should note that all accounts awarded by the CRT are published upon release on the CRT's website at www.crt-ii.org.

Right of Appeal and Request for Reconsideration

Pursuant to Article 30 of the Rules Governing the Claims Resolution Process, as amended (the "Rules"), the Claimant may appeal this decision or submit a request for reconsideration within ninety (90) days of the date of the letter accompanying this decision.

An appeal must be based upon a plausible suggestion of error regarding the CRT's conclusions set out in this decision. Any appeals which are submitted without a plausible suggestion of error shall be summarily denied. A request for reconsideration must be based on new documentary evidence not previously presented to the CRT that, if considered, would have led to a different outcome of the claim. Claimants should briefly explain the relevance of the newly submitted documents in view of the conclusions stated in the certified decision.

If more than one account has been treated in this decision, the Claimant should identify the account, including, where available, the Account Identification Number, that forms the basis of the appeal and/or request for reconsideration.

Scope of the Denial

The CRT now considers the Claimant's claim to the accounts of Erich Rogowski closed. Please note that this decision applies only to the Claim Number and Claimed Account Owner identified herein, and that the CRT is aware that the Claimant may have claimed accounts held by other persons or entities both in the Claim Number specified above and in other claims submitted to the CRT.
